








Figure 1. Typical Forward Voltage




Figure 2. Typical Reverse Current




Figure 3. Capacitance vs. V_R, Reverse Voltage

Figure 4. Average Rectified Forward Current vs. Case Temperature (Square, Each Diode)












Package Outline Dimensions (Cont. All dimensions in mm(inch).)
